Attention to all Citizens in Kinney County

Per the Governor's Executive Order GA-32, counties with less than 30 new cases reported over a 14 day period may apply for an exemption from the decreased capacity. Kinney County applied for and was granted an exemption on October 15, 2020, but this exemption was revoked on January 07, 2021 due to a number of newly reported active COVID-19 cases. **We now have 54 active cases.** The county may apply for exemption again after a 14 day waiting period if the cumulative total of new cases drops below 30 within that timeframe.

UNTIL FUTHER NOTICE

- Business establishments that otherwise would have a 75% occupancy or operating limit may operate at up to **ONLY 50% occupancy.**
- Restaurants that have less than 51% of their gross receipts from the sale of alcoholic beverages, and whose customers eat or drink while seated, may offer dine-in services.
- Bars or similar establishment that hold a permit from the Texas Alcoholic Beverage Commission (TABC) and are NOT restaurants are to remain closed.
- In providing or obtaining services, every person (including individuals, businesses, and other legal entities) should use good-faith efforts and available resources to follow the minimum standard health protocols recommended by DSHS.
- Churches in Kinney County are exempt from GA-32

Given the increase in community spread throughout the United States, all individuals are at some risk of exposure to COVID-19. Everyone should monitor themselves for symptoms. Minimizing exposure is especially important for people who are 65 years or older and/or who have underlying health conditions.

CDC has provided guidelines to prevent the further spread of COVID-19, such as

- 1. Wear a face covering**
- 2. Wash your hands often**
- 3. Stay 6 feet apart from others**
- 4. Clean frequently touched objects**
- 5. Do not touch your eyes, nose and mouth**
- 6. Cover your cough and sneezes**
- 7. Stay home if you are sick**
