 - The Assistant District Attorney's salary increased at no additional cost to Live Oak County.
 - New medical staffing for the County Jail.
 - Contracted Dr. Ray Fernandez in Robstown to perform autopsies for Live Oak County.
 - o Contracted Grant Writer, Yvette Utley, with Lone Star Strategy.
 - Approved Lone Star Strategy Group LLC to apply for the TDEM winter Storm
 Disaster Grant and the Building Resilient Infrastructure and Communities Grant.
- Software for Financial Intelligence upgrade for auditor's and treasurer's offices.
- Increased budget \$15,000 for the Live Oak County Historical Commission.
- Purchased new elections equipment first utilized in the November election.
 - More training was approved for county clerk employees and elections workers.
- Senior Center continuing to serve and add people to the meal delivery program.
- Purchased 12 Automated External Defibrillators.
- Visited with Union Pacific about railroad crossings in Live Oak County.
- Met with TXDOT about intersections and roads in Live Oak County.
- Received 2 used vehicles for constables from the City of Three Rivers.
- Presided over 220 Criminal Cases from October through December.
