The Certificate of Compliance demonstrates the outstanding leadership and the diligent work of the staff in complying with minimum jail standards and is a direct result of the commitment to excellence.
- Continuing to work with Coastal Plains to provide a Mental Health Facility in Live Oak County and initiating a Jail Diversion program.
- The Commissioners continue to pave, repair, and improve the roads in their respective precincts.
- Commissioners' court met with the Texas Association of Counties to begin a 5-year financial plan.
- Built 3 additional storage units.
- Traveled to Washington, D.C. for the inauguration and attended meetings and balls.
- Met our new TXDOT engineer and expressed road concerns.
- Commissioners' Court purchased an additional 6 acres of land adjacent to the Live

Oak County Justice Center for expanding services, including the Coastal Plains Integrated Health Facility and Live Oak County Fire Station.

- Gathered to watch live feed with Sheriff Busby as he was recognized on the Congressional Floor by-Congresswoman Monica De La Cruz.
- Commissioners' Court has adopted an updated the employee handbook.
- Commissioner Kopplin and I met with Conoco Phillips for annual update.
